- Sports schedules are being finalized—parent volunteers will be coaching. We do know that our first game will be 9/24 vs. El Nido at home.
- Mrs. Steiner held a 6th grade camp meeting last night—students are scheduled to attend Camp Green Meadows 10/6-10/10.

- RESULTS testing wrapped up last week; we have intervention groups established now at both campuses.
- We met with teachers individually two weeks ago to review their test score growth and discuss performance from SBAC data.
- Starting today, we have a new lunch procedure at Dairyland. Students present a barcoded card to teachers to scan. This process will eliminate the need for the cafeteria to be silent as students walk through the line with their trays.
- We have learned that we will have a cafeteria review this year. Some documentation will be submitted prior to site visits—those in-person reviews will take place early in 2026. Our staff had two virtual training sessions Monday and Tuesday mornings.
- STEM starts this week at Alview. STEM GATE started yesterday at Dairyland.
