Alview-Dairyland Union School District held a public hearing on September 8, 2020, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. Core subject textbooks and instructional materials are provided for each student, including English learners. Standards-aligned texts and materials are reserved both for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the state are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. The table displays information about the quality, currency, and availability of the standards-aligned textbooks and other instructional materials used at the school. In addition to textbooks, all students have a school issued computer and if needed, a hotspot to provide connectivity for distance learning access.

School Facility Conditions and Planned Improvements

Dairyland Elementary School was originally constructed in 1915 and is comprised of nine classrooms, multipurpose room, library, staff lounge, and a playground. Facility and inspection information is current as of December 2020.

Cleaning Process:

The Director of Operations works daily with the custodial staff to maintain the cleanliness and safety of the school. The district governing board has adopted cleaning standards for all schools in the district. Due to COVID-19 protocols, new procedures were implemented in the fall of 2020 to disinfect classrooms, restroom and play equipment at specific intervals throughout the day. A summary of these standards and protocols is available at the district office for review.

Maintenance and Repair:

District maintenance staff ensures that the repairs necessary to keep the school in good repair and work orders are completed in a timely manner. A work order process is used to ensure efficient service and highest priority are given to emergency repairs. At the time of publication 100% of restrooms were in working condition.

School Safety Plan (School Year 2020-2021)

The safety of students and staff is a primary concern of Dairyland Elementary School. The school is always in compliance with all laws, rules, and regulations pertaining to hazardous materials, state earthquake standards, pandemic protocols, etc. The School Site Safety plan was last reviewed and updated in August 2020 by the school faculty. All revisions were communicated to both the classified and certificated staff. The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster. Fire, disaster, and lockdown drills are conducted on a regular basis throughout the school year. For 2020-21, a COVID Prevention Program and Safe Reopening Plan were added.

Students are supervised before and after school, during lunch, and break periods. The school provides two-way radios to enable those who are supervising students to maintain communication. There is a designated area for student drop off and pick up. Visitors must sign in when entering the campus. Students coming and going during the school day must be signed in and out. Security cameras are around the perimeter of the school and one is in the cafeteria for student and facility safety.
