Alview-Dairyland Union School District held a public hearing on September 10, 2019, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. Core subject textbooks and instructional materials are provided for each student, including English learners. Standards-aligned texts and materials are reserved both for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the state are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. The table displays information about the quality, currency, and availability of the standards-aligned textbooks and other instructional materials used at the school.

School Facility Conditions and Planned Improvements (Most Recent Year)

Alview Elementary School was originally constructed in 1962 and is comprised of eight classrooms, multipurpose room, library/STEM building, and a playground. The school recently resurfaced the old parking lot, painted the buildings exterior, and added a new portable library/STEM building. Facility information is current as of December 2019.

Cleaning Process:

The Director of Operations works daily with the custodial staff to ensure that the cleaning of the school is maintained to provide for a clean and safe school. The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards are available at the district office for review.

Maintenance and Repair:

District maintenance staff ensures that the repairs necessary to keep the school in good repair and work orders are completed in a timely manner. A work order process is used to ensure efficient service and highest priority are given to emergency repairs. At the time of publication 100% of restrooms were in working condition.

School Safety Plan (School Year 2019-20)

The safety of students and staff is a primary concern of Alview Elementary School. The school is always in compliance with all laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. The School Site Safety plan was last reviewed and updated in August 2019 by the school faculty. All revisions were communicated to both the classified and certificated staff. The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster. Fire, disaster, and lockdown drills are conducted on a regular basis throughout the school year.

Students are supervised before and after school, during lunch, and break periods. The school provides two-way radios to enable those who are supervising students to maintain communication. There is a designated area for student drop off and pick up. Visitors must sign in when entering the campus. Students coming and going during the school day must be signed in and out. Security cameras are around the perimeter of the school and one is in the cafeteria for student and facility safety.
